## Consumer Engagement Design Team Meeting Notes

### Agenda item: Finalize Consumer Engagement Language

Scott Wituk provided the design team and other members of the Stakeholder Working Group (SWG) in attendance an overview of the work on consumer engagement to date. The next round of consumer engagement will take place until September 2019, with the goal of using the next wave of engagement to inform later question development by the SWG. At least five organizations have expressed interest in partnering to engage consumers on behalf of the KMMC.

The design team then reviewed the most current version of the consumer engagement script and questions, with the goal of finalizing the script and questions at the end of the meeting. The group provided feedback on the script, including referring to KanCare predominately as Medicaid throughout, as some consumers may not always equate Medicaid and KanCare. The group also expressed keeping the highlighted portion of the script, which was a new addition.

The group also provided feedback on the specific questions, including changing the question, "What do you wish the Governor knew about KanCare" to "What message would you want to take to the Governor about Medicaid in Kansas (KanCare)?"

## Agenda item: Review Informational Questions Posed by SWG members

Kari Bruffett reminded the group of the set of informational questions that had been submitted previously by SWG members. Since the last SWG meeting, the set of informational questions had been divided into policy-focused questions (to be addressed by the SWG/KHI) and data-focused questions (to be addressed by the DRWG).

The SWG then discussed whether and how to tackle the additional informational questions. In general, the group expressed support for the template format, with the addition of a "key findings" section.

When discussing how to answer the questions, SWG members suggested that it would be important to understand the original intent and underlying meaning of the questions.

While many of the questions focus on processes in KanCare (e.g., how to access specific services), the questions may have been raised due to issues experienced at specific points in the current process. The SWG discussed that it would still be important to understand the current processes, which may help advocates point to where current issues may be occurring.

The SWG then reviewed the list of questions to discuss which to tackle initially and discussed what would be important to consider when answering the questions. Below are the questions the SWG selected for KHI to address ahead of the September meeting, and if discussed, considerations to address when answering each question.

Question 66. "What services are available in KanCare to help enrollees avoid institutionalization or loss of independence? Do MCOs have financial incentives to limit enrollee's ability to stay in a home environment?"

 Considerations: The SWG discussed that while there are financial incentives in place intended to encourage managed care organizations (MCO) to keep consumers out of institutional settings, anecdotally some SWG members have heard of consumers experiencing the opposite. The SWG suggested examining whether current policy supports avoidance of institutionalization. It was also suggested that the group review the recent DRC report on NFMHs and NFs. Question 74-76b: "What services are available that facilitate employment opportunities for youth? What services are available that facilitate employment opportunities for adults with significant disabilities? What services are available to facilitate employment opportunities for adults? What additional services would help enrollees find employment?"

 Considerations: One SWG member offered to send a recent report from the Employment Systems Change Coalition that provides an overview of employment services and policy recommendations. Link to report: <u>https://www.drckansas.org/publications/ESC/esc-report/view</u>

Question 53. "There are so many more questions related to quality of care, it is hard to know where to start. I would be interested in knowing how KanCare selects their performance measures related to quality of care - are we truly measuring what is most important?"

Question from 6/13: "Participation in certain KanCare services; particularly the HCBS Frail Elderly and Brain Injury Waivers has dropped significantly from pre-KanCare numbers. What systems are in place to ensure access to these services hasn't been adversely affected by KanCare processes, eligibility evals, rules etc."

• Considerations: Because the first portion of the question centers on data, focus answer on what systems are in place to ensure access to HCBS services aren't impacted by KanCare processes, eligibility evals, rules, etc.

# Agenda item: Revisit National Consultant

Sydney McClendon described the work so far towards engaging a national consultant to inform the work of the KMMC. McClendon indicated that supporting a national expert was part of the interest of the KMMC funder. The group discussed the trade-offs of engaging external expertise now - potentially regarding consumer engagement or other time-sensitive tasks – versus later on topics that may include validated quality measures that may be new to Kansas. There was concern expressed that engaging an expert in the short-term may slow the progress of the group. Others noted the value of starting with best practice and looking for opportunities to meet or exceed it. Another strategy proposed was to send a KMMC member to a meeting where information on best practices related to the work of the KMMC would be discussed. It was also suggested that the KMMC could commission an ECHO Hub to make the learnings available broadly, across the state.

# Agenda item: Discuss KMMC Annual Report Outline

Kari Bruffett described the draft Annual Report Outline. Bruffett noted that this would be an interim report on the progress of the KMMC to-date. This report will support a key KMMC aim of a shared understanding of KanCare. Bruffett shared that the initial goal was to make this report available by August 31. However, Bruffett noted that it has been suggested, but not confirmed, that the next meeting of the Bethell committee will be the last week of August so it may be necessary for the report to be available ahead of schedule. The group recognized that the report is not being made at the request of the Bethell committee, but that the committee will likely be interested in its content. Further, the group discussed how the report should be reviewed and decided that the Executive Committee will review the draft report. It was also discussed that those who have led sub-groups, such as the Consumer Engagement Design Team may provide input on the items and process related to that work.
