

Reopening Plans for Kansas Counties: Ad Astra Plan Modified Phase Two (June 2, 2020)



Effective Through May 26 | As of 5 p.m., May 22

Counties that have announced restrictions and closures that differ from the State Plan are identified in the report. Counties may have orders in place that were not identified by this approach and therefore are not identified properly in the table. Information will be monitored and the table updated regularly.

| Brown | Buffets and salad bars remain closed. |
| Cloud | Self-serve food or beverages and buffet style dining is not allowed. |
| Finney | Remains in Phase 1.5 until May 31. |
| Gove | Masks required in public and retail locations. Salon and barbershops must allow only one patron at a time. Customer log must be kept at salons, barbershops, fitness centers and gyms. |
| Harvey | In-person visits to long-term care facilities and correctional facilities are prohibited. |
| Morris | Self-serve food and beverages, and buffets are prohibited. In-person visits to long-term care facilities are prohibited. In hair salons and barbershops, limit one customer per service provider. At Farmer's Market, limit one customer per vendor at a time. Recreation activities and organized sports must follow mass gathering and social distancing guidelines. |
| Nemaha | Self-serve buffets and salad bars are prohibited. Self-service of unpackaged food is prohibited. Bar seating is prohibited. No refillable cups are allowed at self-serve drinking stations. In-person visits to long-term care facilities and correctional facilities are prohibited. |
| Ness | Restaurants and grills are limited to 30 percent of their total capacity and self-serve buffets are not allowed. Indoor leisure spaces are not allowed to open. |
| Pawnee | May not provide service at the counter, may not allow a waiting line, and no public self-service salad bars and beverage stations are allowed. |
| Rice | Dine-in must adhere to social distancing, self-serve beverages are allowed if clean, disposable cup used, and buffets and salad bars allowed if monitored. For retail businesses, limit customers in retail businesses to 5 customers per 1,000 square feet, and employees must wear masks. No outside visitors are allowed at long-term care facilities. For personal services, service provider and customer must wear masks, customer log must be kept, one customer is allowed per service provider and customers must be screened. No organized sports tournaments. |
| Riley | Requiring restaurants to close at 10 p.m. County order also includes retailer compliance and enforcement provisions. |
| Shawnee | In restaurants, shall monitor waiting lines, employees shall wear masks, people with symptoms shall not enter premises, cannot provide service at counter and may not allow self-service of food or drinks from common areas. For retail businesses, employees shall wear masks, shopping carts shall be disinfected by staff, hand sanitizer shall be readily available, marks shall be applied for checkout. For personal services, customer and provider shall wear masks, one customer is allowed per personal service provider, and may not provide service if mask may not be worn. In gyms/fitness centers/health clubs, staff shall be on premises, employees shall wear masks, equipment shall be spaced 6 feet apart, and shared mats or rolls are not allowed. Regarding real estate, all individuals shall wear a mask and no open houses are allowed. Entertainment venues (i.e., indoor leisure spaces such as theaters) can only operate at 50% capacity, and employees in contact with public must wear masks. |
| Stanton | No self-serve food or drinks. Stanton County Long Term Care and Memorial Living remains closed to visitors. Sports gatherings continue to be postponed. No golf tournaments. |
