

Change in KanCare Enrollment by County, February 2020-June 2022

The Kansas Health Institute (KHI) studied Medicaid enrollment during the pandemic and identified neighborhoods that may be most at risk of disenrollment once annual reviews and eligibility redeterminations resume. Using enrollment data provided by the Kansas Department of Health and Environment (KDHE), KHI identified neighborhoods where KanCare enrollees may be at higher risk of disenrollment once unwinding begins. Two criteria were used to evaluate neighborhoods, excess growth in coverage and churn.

- 1. New enrollees in neighborhoods where KanCare enrollment grew more quickly during the pandemic than before the pandemic are assumed to be at higher risk of disenrollment once unwinding begins.
- 2. New enrollees in neighborhoods that experienced higher rates of churn, where people re-enrolled in Medicaid within one year after being disenrolled during an eligibility redetermination, are assumed to be at a higher risk of being disenrolled once unwinding begins.

Figure 2 shows KanCare enrollment growth by county from February 2020-June 2022. It also shows the percentage of new enrollees by county who may be at a higher risk of disenrollment.
