Setting the Stage: Medicaid in Kansas Overview



Medicaid and the Children's Health Insurance Program (CHIP) in Kansas



Medicaid: Enacted in 1965, it provides coverage for health services and long-term care to eligible low-income dependent children, parents, pregnant women, people with disabilities and older adults, as well as some individuals with specific health conditions.



CHIP: Adopted in Kansas in 1998 and implemented in 1999, it provides similar coverage to uninsured low-income children who are not eligible for Medicaid, but who can't afford private coverage.



Financing Medicaid and CHIP

- Jointly funded by the federal government and states.
 - By law, every state receives at least a 50 percent match in federal dollars. Federal Medical Assistance Percentages (FMAP) vary by state.
 - Medicaid: 60.97 percent in Kansas (for every \$1 that Kansas spends on Medicaid, the federal government contributes \$1.56)
 - CHIP: 72.68 percent in Kansas
 - The federal match rate that had been enhanced during the pandemic is phased out in 2024.



Differences Between the Medicaid and Medicare Programs in Kansas

Medicaid


- Medical care and long-term care coverage for low-income children and pregnant women, and some low-income parents, adults age 65 and older and individuals with disabilities.
- Administered at the state level, within federal guidelines.

Medicare

- Provides benefits for adults age 65 and older, some people with disabilities who
 qualify for social security benefits or who are receiving treatment for end-stage
 renal disease.
- Provides medical care coverage, but very limited long-term care coverage.
- · Has no income limit.
- Receives federal funding collected by payroll deduction and administered at the federal level.

Dually Eligible

- Medical care coverage for low-income adults age 65 and older and low-income individuals with disabilities who qualify for social security disability benefits.
- Medicaid pays for Medicare premiums, out-of-pocket expenses and additional services not provided through Medicare such as long-term services and supports.
- Administered at the state and federal levels.



State Plans, Amendments and Waivers

- The federal Centers for Medicare and Medicaid Services (CMS) approves a State Plan for the Medicaid and CHIP programs in each state. It is a contract between the state and federal government describing:
 - How it will administer the program
 - What services will be covered
 - What groups will be eligible
 - How much it will reimburse providers
- The State Plan can be changed by an Amendment or Waiver



Medicaid and CHIP Average Monthly Enrollment and Annual Expenditures in Kansas, FY 2008-2023







KanCare Measures, Oversight and Evaluation

 How Kansas assesses the performance of its Medicaid program, KanCare. It involves identifying measures about the quality of health care services, patient outcomes and cost-effectiveness.

Managed Care

 Managed Care Organizations administer Medicaid services to enrollees. These organizations are responsible for coordinating care, managing health care costs and improving the quality of services provided to Medicaid beneficiaries.



Behavioral Health

 Behavioral health, as it relates to Medicaid in Kansas, encompasses both mental health and substance use disorder services. It involves the prevention, diagnosis and treatment of emotional, psychological and addiction-related issues.

Access to Care

 Includes various issues related to the availability and access to services, health-related social needs (e.g., transportation, child care, employment, etc.), the workforce that serves Medicaid enrollees and rural communities, among others.



Covered Populations

 Medicaid provides coverage for health services and long-term care to eligible low-income dependent children, parents, pregnant women, people with disabilities and older adults, as well as some individuals with specific health conditions.

Home and Community Based Services

Medicaid provides long-term care services to individuals with disabilities, older adults and others with significant care needs, allowing them to receive assistance outside of institutional settings such as nursing homes. HCBS is delivered through waivers, which are designed to offer flexible care options, enabling eligible individuals to live independently in their homes or community settings while receiving medical and support services.



Recent Developments, Policies and Initiatives

This could include administrative policy changes, legislative activity (e.g., post-partum coverage extension), initiatives focused on addressing social determinants of health, and other actions related to the Medicaid program in Kansas.


Innovations
