



# **Hamilton County**

The County Health Rankings & Roadmaps data release provides a snapshot of the health of each county in two summary scores: Community Conditions (which measure issues that can shape population health & well-being) and Population Health & Wellbeing (which measures length and quality of life). ### What do these drivers mean?

The drivers indicate the measures with the greatest impact on the health of the county, according to the CHR&R model of health and county performance.
