

## Stafford County

The County Health Rankings & Roadmaps data release provides a snapshot of the health of each county in two summary scores: **Community Conditions** (which measure issues that can shape population health & well-being) and **Population Health & Wellbeing** (which measures length and quality of life). Each county is placed on a continuum from least healthy to healthiest in the nation and is categorized into a health grouping of counties with similar summary scores. The following tables illustrate the "drivers" for the health of this county.

### What do these drivers mean?

The drivers indicate the measures with the greatest impact on the health of the county, according to the CHR&R model of health and county performance. Drivers labeled with a green plus sign are measures where the county performed better than the average of counties nationwide. Drivers labeled with a red minus sign could be improved and may warrant additional attention.
