Steven M. Corbett, M.A., Ph.D., Senior Chronic Disease Epidemiologist, Kansas Department of Health and Environment

Steve Corbett is a Senior Epidemiologist and Director of Population Health, Maternal Child Health, and Chronic Disease Epidemiology at the Kansas Department of Health and Environment (KDHE) where he oversees the epidemiological activities of programs in the Bureaus of Health Promotion, Family Health, and Epidemiology and Public Health Informatics. The focus of much of his work has been on the social determinants of health and health disparities. He has contributed to articles on cancer burden, historical disease trends, medicinal plants, health disparities, and the health impacts of climate change. He received his doctorate

in biomedical anthropology from the University of Kansas.
